- 7) **New Business:**

- a) **Invite other clubs** to join our 3.5 C League – all Captain's agreed to be ambassadors to other clubs encouraging them to field a C-team. Clubs mentioned were Timuquana, Eagle Harbor, Eagle Landing, St. Augustine/Marsh Landing, Palencia, March Landing/Plantation, Sawgrass, ATP, Queen's Harbour, Jax Golf, and Ponte Vedra, among others.
- b) **Seven partnership** vs. five-partnership teams – reconfirmed by vote of 6 to 3
- c) **New Rule #20** passed unanimously to allow clubs with limited tennis participation to field combined teams (ex. SG/OB or ML/ATP) in the League. Exact wording of Rule #20 will be: The League may accept application to the League by partnerships of clubs where the individual rosters of each club cannot fill the League required minimum roster of 20 players. In these cases, merged teams of more than one club may be accepted to the League by a majority vote of the current clubs.
- d) **Match Day Roster Stacking:** The Captains reconfirmed Rule #10 concerning strength against strength and a gentleman's agreement that no player should move down more than two positions from match to match.
