Re: C League Captain's Meeting 8/24/93

Motion to replace the first sentence of Rule 4 of the 3.5 Div. of the Country Club Men's Doubles Tennis League, which reads as follows:

Each team will play every other team (currently referred to as a "Round Robin" format).

To be replaced with the following:

The league will have two conferences, an upper and lower, with two divisions each. The end of the 92-93 season 16 team rankings will serve as the starting point. The top 4 teams will form C1. The next 4 will form C2 with the inclusion of 1 new team, Deercreek, bringing C2 to 5 teams. The next 4 teams, and C4 will form C3 by the last 4 teams. C1 and C2 will constitute the Upper Conference and C3 and C4 will constitute the Lower Conference. Conference and division teams for the next year (94-95), will be determined by the previous end of season rankings (93-94). The bottom ranked team in C1 will flip with the top ranked C2. The bottom 2 teams in C2 will flip with the top 2 teams in C3. The bottom team in C3 will flip with the top team in C4. Depending upon the number of teams in the league in any given year, there may be more or less teams in each conference and division. In years in which the league has an odd number of teams, or a number of teams not divisible by 4, there may be more teams in one or more divisions than in others.

The schedule of matches will be as follows:

C1 plays each other home and home. They will also play C2 teams once.

C2 plays each other home and home. They will also play C1 teams once.

C3 teams will play each other home and home. They will also play C4 teams once.

C4 teams will play each other home and home. They will also play C3 teams once.

In this way each team will play other teams of similar strength, building on the accepted reasoning that originally established A, B and C Leagues in the first place.

Motion to replace Rule 14, which concerns playoffs, with the following:

There will be no playoffs. The end of the regular season win-loss record will determine the champion of each division. The champion of C1 will be recognized as the overall champion of the C League. The C1 runner-up will be recognized as the runner-up of the C League. The best team in C3 will be recognized as the champion of the Lower Conference.

At the end of each season the remaining monies in the C League Treasury, after all mail expenses, including allowance for one mailing during the summer before dues are collected for the next season, will be distributed as follows:

50% to the winner of C1, Champion of the C League

30% to the runner-up of C1

20% to the winner of C3, the Champion of the Lower Conference

Each division winner, and the runner-up of the C1, should be provided a suitable for framing, 8 1/2 x 11 certificate, recognizing their achievement. The League Coordinator will prepare these.
