Revised Rule 11c to read in its entirety as follows:

Substitutions from other teams: C1 team players should not be allowed to substitute on a C2 team. Similarly, B team members cannot sub on C teams. B players can drop from B roster to C roster as long as they have not played more than 3 matches at the B level and can be certified by pro that they are not rated better than 3.5. Once they drop to C roster, they cannot go back up to B for remainder of that season. Similarly C1 cannot drop to C2 after 3 matches have been played on C1 team@
