- a) Vote on continuing the League unanimously in favor. So far, 6 teams have committed to playing the 2011-2012 season. They are: Ponte Vedra, Hidden Hills, PV Golf and CC (formerly OakBridge), Deercreek/Deerwood, Williams Y1, and Selva Marina.
- **b) Number of partnerships** was discussed beginning with choices of 5 or 7. Mike Lucey, HH, suggested a revision to Rule 4b. to read that

"Each match will consist of 6 doubles court contests. In the case of a 3-3 tie among the 6 partnerships, 2 players from each team will be chosen by the respective team captains to play each other in a deciding tie-breaker. In the case of the tie-breaker, the winner will be the first partnership to a minimum 6 points, winning by a margin of 2 points."

Earnie Franklin, PV moved for acceptance, Dick Mulvey, PVGCC, seconded, the motion was accepted unanimously. In the view of the group, this rule change addresses at least two issues, the difficulty for some teams to produce 7 partnerships on any one Sunday and adding a reason for players to stay and support the team to the end of the match (adding drama to some matches with a gladiator ending! LOL)

In a related issue, Rule 1b. is revised to read "that they have a minimum of 6 soft (clay/particulate) courts available simultaneously for all matches"

This is to allow clubs with only 6 courts to participate in the league who are otherwise qualified.

Matches will continue to be played as usual on Sunday afternoon, 1PM warm-up, 1:30PM match with no Jaguar home game dates between late Sept and early Feb. (avoiding Spring USTA schedule).

c) Rule 12 Match Reporting: Tenniscores.com will be employed to keep track of all individual match reports for the upcoming season. A note with login and password will be forthcoming. The first step will be for each captain to enter their roster information at the web site. During the season home captains will enter match results and visiting captains to verify the entries.

Rule 12 was revised to accommodate this change in the match reporting procedure to read:

"The results of the team matches must be entered by the home captain at tenniscores.com within twenty-four (24) hours after the match has been played, and verified by the visiting captain. A signed paper score sheet should be keep by each captain for back-up records should tenniscores.com have a technical issue."
